

***IdaVend Broadcasting, KRPL, Inc.  
and Inland Northwest Broadcasting  
General Contest Rules***

**1. Dates/Terms/Eligibility.** IdaVend, KRPL Inc. and Inland Northwest Broadcasting (the “Station” or “IdaVend,” or “KRPL,” or “Inland Northwest Broadcasting”) may change the dates and/or terms of the Contest without prior notice. Any material changes will be broadcast on the station. The Contest is open to all legal U.S. residents, living within 100 miles of Moscow, or Lewiston, Idaho or Pullman or Colfax, Washington unless otherwise specified. There is no purchase necessary to enter or win. Employees or agents of the Station, specific contest promotional partners, their parent companies or subsidiaries, other radio stations or any entity associated with the Contest, as well as members of the same household of any such employee or agent, may not participate.

**2. Prizes.** Only one winner or qualifier per household per 30 days. All sales, prize and other taxes, gratuities and any other incidentals associated with the prize are the sole responsibility of the prizewinner. Prizes are not transferable or exchangeable and may not be substituted, except by sponsors for reasons of unavailability. In which case, a prize of equal or greater value will be awarded. Translation: In essence, prize winners receive a service or an item that they do not have to pay for. That is taxable income for income tax purposes. Since the radio station is the business that gives away the prize we have to take care of the 1099. So you need to have the winner complete a W-9 which gives us there taxpayer information so we can complete a 1099 for them at the end of the year.
